- 7) That the school will ensure compliance of all statutory requirements like EPF, ESI and labour laws etc. With respect to the school and staff of the school.

- 9) That the school will ensure that all required infrastructure is available with the school before starting classes.
  - 10) That the school will ensure that sufficient number of qualified teacher as per the provisions contain in affiliation bye-laws are available with the school before starting classes.
